Card Index to Loyalists of Bergen County

This card file index identifies 326 Bergen County Loyalists and sources of information about them. Some of these "loyalists" were called before the Council of Safety and cleared their names. Sources include *New Jersey Archives Series, New Jersey Historical Society Proceedings*, and the Royal Claims Commission. Unsourced information is also reported on these cards. The researcher should use care, as with any compiled source.

After the introductory letter and cards, the loyalists are arranged alphabetically. The text is also full-text searchable.

PATRIOTS AND LOYALISTS OF BERGEN COUNTY, NEW JERSEY.

The compilation of nine hundred and twenty five cards contains war records and biographical material of Bergen County Soldiers and Patriots of the American Revolution. It is far from complete and possibly in certain instances needs correcting. As years pass additional information might be established by further research. Individuals may feel slighted that their favorite ancestor has not been listed, but this is due to incomplete information.

The three hundred and twenty six cards for Bergen County Loyalists may surprise some people, but all of these names were not necessarily active Loyalists. They were listed as such by the New Jersey Council of Safety which was disbanded in 1778. Persons who were brought before the Council frequently cleared themselves of charges laid against them by malicious or other informers.

We know that Bergen County had many more names which could be added to the list of Patriots. Those citizens infirm, cripled or too old to bear arms loved their country dearly, giving money and moral support to the local militia. Certainly they should be listed as Patriots.

Weart was born in 1743 died 1795. Was of Paramus. Perhaps the most notorious of all Bergen County loyalist. He lived in N.Y. but was forced to quit the city in 1774 for being a Tory or he would have been tarred and feathered. Because of his knowledge of New Jersey country-

side his reconnoitering activities kept him away from headquarters and delayed the granting of his commissionnas a Lt. in the King's Militia Vol. until 2-2-1779. He served in Capt. Peter Earle's Co. and on 3-28-1779 in the skirmish led by Col. Van Buskirk against Americans between Hoboken & Closter was hit in the knee by a musket ball and sustained an injury which crippled him for life. He was carried to N.Y. where he stayed until he sailed for Shelburne. Was son of Cornelius Banta who died about 1787. British Gov. granted him an allowance of 70 pounds from 1788 to 1804 but he died in 1795. Whether his wife Elizabeth returned is not certain, but it is said she resided with grandson Weirt and died aged 84 on 4-19-1833 at the city on Christopher Street.

Claim was for 309 pounds, had real estate received 380 pounds

He was born in Sidwell, Exeter, England in 1702 came here in 1748. On 12-8-1769 bought 110 acre farm at English Neighborhood from the Moores. Before the Rev. he commanded a militia called the Gov. Guards in the city. When the war broke out he received offers of any rank in the Continental Army under Washington if he would

join them. He refused to sign the Association, we was obliged to flee aboard the "Duchess of Gordon" in 6-1770. Gov. Tryon of N.Y. appointed him a Capt. in N.Y. Rangers. In order to save his N.J. farm he rented it. He sold it to Timothy Hurst a loyalist but the property was confiscated and sold as Benson's in the spring of 1784 dispite Mr. Hurst's efforts to stop the sale. Benson along with his son (Jr.) is listed as original grantees in Clements, Nova Scotia. He died in 1805

Matthew jpined the King's Orange Rangers and recruited men for Colonel Bayard's Regiment, until he went to Halifax when he was discharged and worked in the King's Brew House until the evacuation of N.Y.. His land at Mahwah was sold to Coonradt. 32-6-10 acres. Book D. of Deeds page 345

His property was confiscated at the January term of Court 1780. In 1787 he was living at Cataraqui, Canada. Records in A.O. 13:17, A.O. 12:63,f.126) A.O. 12:109

BERRY LOYALIST

John- Clayton's History page 65 There was an Englishman by the name of John Berry called John the Regular who was a terror to this section of the country during the Revolution. The Government at one time offered 1,000 Ls for his apprehension. During one of these frequent raids from the olf Block House, some companies of militia under Captain Blanch and Van Valen were sent out from their redezvous at Tappan to interrupt a foraging party of British and Refugees. They met the party near the Liberty Pole where an engagment took place. In this one engagment, Berry

who was with the enemy was shot and was discovered concealed by a fallen tree by Samuel Van Valen and James Blauvelt who knew him to be Berry and raised their guns to fire upon him whereupon he begged for his life and surrendered. He was then mortally wounded. They brought him in a wogon to Hackensack and buried near the present Kansas Street.

(Abandoned Grave yard of the True Reformed Dutch Church.)

Thomas was of English Neighborhood. He was a guide to Cornwallis. He placed a claim in Royal Commission for losses and services of American Loyalists. The claim was disallowed He listed real estate in Bergen County 400 L He was an Irishman. In 1775 he purchased 12 acres from his father-in-law Thomas Moore who was a patriot. Thomas joined the British

in 1776 and acted as a guide for Cornwallis's forces in N.J. He went to England in 1786. His wife was Maria born in 1751. Probably married by Rev. Garret Lydecker in 3-2-1771. His wife and her family were loyalists and after her father's death in 177 one of her 2 brothers lived in the Blakeney house, presumably to identify himself against losses of the family

He served as an Express for 17 months and was pressed into the Royal Navy. His wife did not go to England, remained here, remarried.

The Reverend Garret Lydecker (Q.V.) in evidence in London on 11-22-1786 was doubtful of Blakeney ownership of the house and land which he claimed as his father-in-law, Thomas Moore had taken possession of his property before the Revolution because of a dispute between Blakeney and his wife, who had since married again. The pastor had a bad opinion of the Irishman's conduct as a "private man." His memorial of 3-14-1788 is endorsed: "The Board cannot do anything fir him." A.O. 13:108; A.O. 12:109

Theunis Blauvelt , married Catherine De Baun and their daughter Maria married Abraham Haring. He died in 1810 and Maria married a former American patriot- Peter S. Van Orden see pg 47- Blanvelt Gen, by Louis Blanvelt,

Theunis had a claim to the Royal Commission on losses and services to the American Loyalists for 223-6-3- he had 108 acres in Bergen County. His compensation was 128 pounds Sabine- 1: 232 Born 1747 died in 1830. Born in Tappan, but when the war broke out he was living in this county. He owned 54 acres-having acquired 442 acres from his step-father John Fleerboom in 1772. He signed the Association Test early in the war to avoid being sent to jail, but joined the British -1776 Was a Lt. in the King's Militia of Volunteers. Often acted as a spy and guide for British forces His 1st wife died during his absence. He went to Argyle co. in Nova Scotia in 1786. In 1788 he married Hannah Van Orden only 19 dau-Cabriel

Browned himself drew up the other by which it was engaged to comply with the legal orders of Congress, and this Association was adopted at the meeting again st the violent one of Morris. His reason as given by him for drawing up this Association paper was to prevent people from signing a worse. He remain ed quiet until the arrival of the British troops in New Jersey, having been exempted from serving the militia by reason of his profession as a

Mr. Browne was a Committeeman and a member of the Provincial Congress in 6-1776, a course taken by him on 5-3-1777, advising this course, was produced before the Commissioners in London. He could not be a member of the new Legislature in 9-1776 because he would not take the oath of abjuration of the King. He claimed that the majority of the inhabitants of Bergen County were Loyalists. The records of that county were carried away by him to N.Y. at some personal expense and danger. His commission as Major of the 1st M.J. Vol. is 11-17-1776 *He went to Annapolis at the end of the war. A.O. 13:83; A.O. 12:15,ff. 98-110; A.O. 12: 63, ff. 14-15; Ind. 5605; Ontario Archives 541-3

The old Hopper homestead on the Pollifly Road a division of soldiers made themselves at home for a number of weeks, the officers sleeping in the house and the common soldiers under the trees in the orchard, immediately back of the house. One night Mrs. Hopper was awakened from her slumbers by noises among the pigs in the pig pen. Mrs. Hopper at once aroused the officer and requested them to investigate the cause of the disturbance. They thereupon ran out into the darkness in the direction of the sounds and discovered one of their soldiers in the act of carrying off a struggling pig.

Considering the miscreant as a poocher on their own preserves the officers flogged him so severely that neither he nor any of his comrades ever afterwards repeated the experiment. It is not related whether Mrs. Hopper's pleasur at the rescue was of long duration, but it is probably that His Magesity's officers had as keen an appetite for Pork as their subordinates and that the pigs were soon a thing of the past.

His knowledge of the German language was exercised in influencing the Germans in N.J. to remain loyal.

She went to England in 2-1780 and was support ed by her brother-in-law until his death in 4-1781.

He was born 1737.A farmer. Accused of disaffection to New Jersey and arrested 7-11-1777 and his estate was confiscated the following year. On 8-2-1778 he was confined to Morristown Jail. In a petition which he sent to the N.J. Legislature he said that upon the arrival of the British Troops in 1776 his 7 horses and 29 neat cattle, the whole stock of his farm were carried off by the enemy. He took the 1st opportunity of going to Bergen and thence to Staten Island to procure compensation from the British

for the properties they had taken from him. He declared that the groundless reports circulated about him made him fearful both to return home and to stay where he was until 7-1778 when he went home. He declared he had never li lifted his arm against the state nor gave the least degree of aid to the enemy. Although no further record has been found with respect to the subject of his petition, it is possible that he retained possession of his land since he conveyed a farm of 250 acres to his son Michael D. The only person in Bergen County to regain his citizenship after the forfeiture of his estate. He had been captured while carrying produce to the enemy and was indicted in 1781 for the misdemeaner. He was found guilty and sentenced to the Sussex Jail and to stay within ten miles of it for one year. Twenty pounds out of his estate was to be paid Lt. Paul Paulisse and others who had taken Westervelt and his provisions on the way to the enemy. On 1-31-1804 Westervelt who was over 75 years of age at the

time asked the New Jersey Legislature to repeal his disfranchisement so he might be restored to the rights of citizenship and to be able to possess property. His request was granted 3-1-1804, He was born 1728 and died 11-25-1810 aged 83 years. His 1st wife was Marytje Lozier whom he married 10-5-1751. 2nd wife was Hannah Brinkerhoff married before 1780
